As part of your role you will work within your own highly specialised scope of practice, holding clinical responsibility for a complex caseload of academic and external clients working individually or as part of a group. Utilising all relevant clinical information, you will undertake specialised assessment of individuals with complex pathologies and communication difficulties. You will encourage learners and clients to partake in an active approach to regaining and maintaining independence, requiring empathy, sensitivity and exceptional interpersonal and communication skills. You will undertake specialised physiotherapy treatments utilising a variety of modalities including gym work, exercise prescription, rebound therapy, aquatic physiotherapy, virtual reality and integration of physiotherapy within the classroom. You will be working independently whilst supervising and progressing others skills. You will set goals and classroom targets with regular review and modification of goals and complex treatments as required, constantly striving for the best level of physiotherapy support for the people we work with. You will instruct students, carers, tutors, learning support assistants and PA's on mobility and physical therapy activities, demonstrating safe use of equipment. You will maintain accurate electronic records in line with chartered society of physiotherapy and department standards, completing audits ensuring compliance. You will be required to contact and work with external agencies regarding student/client care, completing reports when required. You will develop and deliver training to develop staff to a high level within the physiotherapy team, wider multi-disciplinary team and across college and attend any relevant training for further self-development. You will assist other physiotherapists in the delivery of the caseload. You will carry out safe moving and handling practices for moderately to severely dependent complex clients within the college.
